# ASSESSMENT REQUIREMENTS



- ✦ You will be required to submit an assignment for module 1 and a portfolio of evidence for modules 2 and 3.
- ✦ To achieve all 3 units of qualification, you will need to be observed conducting assessments of learners, assessing evidence, and providing constructive feedback.
- ✦ Portfolios of evidence for modules 2 and 3 should include evidence of assessment planning, varied assessment approaches, reflective practice, supporting learners, attendance at standardisation events and ongoing CPD.

## Course Fees

### Level 3 TAQA – Fees Range from £474.00-£810.00 (Inclusive of VAT)

### *Flexible Payment Terms*

For participants who are **self-funding**, we offer interest free instalment payment plan options - to be assessed and agreed on an individual basis. Typically, this is a 50% upfront payment, which is to be paid before the course start date, with the remaining balance paid monthly up to the course end date. We can also accommodate different payment plans to suit individual needs if required. You will be required to sign our self-funding finance agreement at enrolment.

Participants who are **funded by their employer**, should provide a purchase order number at the time of booking and fees are expected to be paid in full before the course start date (7 working days before the course start date).
